EU Country Cancer Profiles

The European Commission and the Organisation for Economic Co-operation and Development (OECD) published the Country Cancer Profiles under the European Cancer Inequalities Registry (a flagship initiative of Europe's Beating Cancer Plan) for EU Member States, Norway and Iceland. The Country Cancer Profiles aim identify to inequalities in cancer prevention and care for each of the



mentioned countries. The Cancer profile for Belgium may be of special interest for our readers.

The European Commission proposes pharmaceuticals reform for more accessible, affordable and innovative medicines

On 26 April 2023, the European Commission published its proposal for a new Directive and a new Regulation, which revise and replace the existing general legislation pharmaceutical including the legislation medicines for children and for rare diseases. The revision aims to achieve timely and equitable access to safe, effective, and affordable medicines; enhance medicines availability, foster innovation, reduce administrative burden, address antimicrobial resistance and make medicines more environmentally sustainable.

This project brings together the leading experts of 57 governmental, healthcare, academic and non-profit organisations from 26 member states and associated countries.

The aim of the project is to establish National Cancer Mission Hubs (NCMHs) in each country. These NCMHs, operating at national, regional and local level, will have a vital role in involving all relevant stakeholders, health and research, and including citizens, in cancer-related policy dialogues on tackling cancer.




Full title: Joint Action Towards the European Health Data Space
