Mini symposium on the DRUP initiative



We are glad to invite your to a mini-symposium on the current status of **the DRUP ("Drug Rediscovery**



The DRUP initiative aims to establish clinical trials that describe the efficacy and toxicity of commercially available, targeted anticancer drugs prescribed for treatment of patients with advanced cancer with a potentially actionable variant as revealed by a genomic or protein expression test. DRUP also aims to simplify patient access to approved targeted therapies that are contributed to the program by collaborating pharmaceutical companies and to perform next generation sequencing on tumor biopsies for biomarker analyses.

We are very honoured to welcome **Hans Gelderblom** (LUMC, NL) who will provide us the state-of play and outcomes of the DRUP trial in the Netherlands and **Kjetil Tasken** (Oslo Univ. Hosp., Nor) who will talk about the organisation of a DRUP-like trial in Norway and the EU4Health projects supporting to implement DRUP-like trials. **Marjan Willaert** (Pharma.be) will provide the view of the Belgian pharmaceutical industry on these initiatives and **Marc Van den Bulcke** (Cancer Centre - Sciensano) will present the new initiative "Belgian Cancer Research Alliance' for Bench-to-Bed Cancer research in Belgium.

CANSCREEN - ECIS



Full title: Strengthening Cancer Screening data collection to update European Cancer Information System and improve quality and coverage of cancer screening programmes in Europe

Main areas: EARLY DETECTION & SCREENING Timeline: 01/09/2022 - 31/03/2024 (2 years)

• At the 1st and 2nd of June, the CanScreen-ECIS project organised a stakeholder workshop at IARC (International Agency for Research on Cancer - Lyon, France). Data providers, screening programme coordinators, policy makers and researchers actively discussed on the data collection needed in preparation of the 3rd report on cancer screening in the EU, with subsequent data upload to the JRC ECIS (European Cancer Information System data) database. There was not only the focus on breast, cervical and colorectal cancer screening, but also creating the opportunity to incorporate new screening programmes (lung, prostate).

Horizon Europe Proposal Workshop

20th September 2023

After a successful first edition in 2022, the Belgian National Contact Points (NCPs) are organising a second edition of the "Horizon Europe Proposal Workshop". After a general introduction about proposal writing, we will split into smaller groups to discuss proposals (mostly from Pillar 2 clusters) evaluated by the European Commission in the past. The discussions will be led by experienced evaluators and NCPs of this field. After a networking lunch, Marc Tachelet and Cecile Menetrey-Monchau, from the European Research Executive Agency (REA), will share key insights and highlights of the first Horizon Europe evaluations. The target audience for this event is limited to the less experienced researchers in proposal writing from Belgian companies, universities, research organisations, public institutes, etc. willing to participate to the programme Horizon Europe as beneficiaries.
