Full title: European Genomic Data Infrastructure Main areas: RESEARCH Timeline: 01/11/2022 - 01/10/2026 (4 years)

• The GDI project has released a 'Starter Kit' to enable access across borders to genomic and phenotypic data. GDI - co-funded by the Digital Europe Programme - is a collaborative project to build secure sustainable data infrastructure required to fulfill the ambitions of the 1+ Million Genomes (1+MG) initiative, which aims to realise the practice of genomic medicine across Europe. The GDI Starter Kit is a key project output that supports federated data access workflows. It will benefit not only the national nodes of GDI, but also in future public institutions and companies who can use the software technologies to increase legal, organisational, semantic and service interoperability by including these software and standards into their own environment.

SIOP Europe and CCI Europe will once again mark the Gold September – Childhood Cancer Awareness Month campaign through this annual flagship policy event hosted by MEP Loucas Fourlas (EPP, Cyprus) in Brussels in cooperation with the MEPs Against Cancer (MAC) Interest Group. This event is is timed to take place during the negotiations on the EU Pharmaceutical legislation proposal and include all relevant stakeholders - including EU institution representatives, parents and patients, academia, industry, and healthcare professionals and approximately 100 participants. The aim is to gather perspectives and trace the way towards an EU regulatory environment that is best positioned to address unmet medical needs.

The Regulation on the European Health Data Space (EHDS) aims to regulate the sharing and (re)use of health data across the EU for both private individuals and researchers or policymakers. With this event, the MEPs Against Cancer (MAC) Interest Group aims to inform the cancer community about the shape the initiative is taking and to discuss: - The impact of the EHDS on cancer prevention, treatment, and survivorship as well as the work of healthcare professionals - The challenges and opportunities for academia and researchers working on improving the cancer research - The role of robust health data for strengthened evidence-based public health and cancer policymaking



Horizon Europe Proposal Workshop

After a successful first edition in 2022, the Belgian National Contact Points (NCPs) are organising a second edition of the "Horizon Europe Proposal Workshop". After a general introduction about proposal writing, we will split into smaller groups to discuss proposals (mostly from Pillar 2 clusters) evaluated by the European Commission in the past. The discussions will be led by experienced evaluators and NCPs of this field. After a networking lunch, Marc Tachelet and Cecile Menetrey-Monchau, from the European Research Executive Agency (REA), will share key insights and highlights of the first Horizon Europe evaluations. **The target audience for this event is limited to the less experienced researchers in proposal writing from Belgian companies, universities, research organisations, public institutes, etc. willing to participate to the programme Horizon Europe as beneficiaries.**

New webpage provides info on EU4Health funded projects delivering on Europe's Beating Cancer Plan

Europe's Beating Cancer Plan is a political commitment to turn the tide against cancer, as part of a strong European Health Union. Europe's Beating Cancer Plan is made up of 10 flagship initiatives and 32 supporting actions. The plan focusses on the entire disease pathway and is structured around four key action areas: prevention; early detection; diagnosis and treatment and; quality of life of cancer patients and survivors. With a \in 4 billion budget, the EU Cancer Plan makes use of all available funding instruments, including dozens of projects financed by the EU4Health programme. The Commission is happy to announce that a new webpage has been created, with information on the currently ongoing 28 EU4Health financed cancer projects, including a video and factsheet. Cancer screening statistics

Eurostat recently published an article presenting an overview of European Union (EU) statistics related to cancer screening. This article is one of a set of statistical articles concerning healthcare activities in the EU which forms part of an online publication on health statistics. While most data in this article relate to 2019, the data from screening programmes are generally for 2021. As such, this article includes data that may have been impacted by the COVID-19 pandemic and its related restrictions. For this reason, particular attention should be paid when comparing the 2021 data with data from earlier years. In some EU Member States, healthcare resources were placed under intense pressure (particularly at the start of the pandemic) from an influx of patients with COVID-19. The pandemic also resulted in a range of knock-on effects including, among others, some services being curtailed/postponed due to the number of COVID-19 patients, staff shortages within hospitals and day care centres due to infection/quarantine procedures, and patients being hindered accessing medical services due to their own infection/quarantine as well as lockdown
